- 6. This contract is binding upon the parents for the full and complete amount from the date of the execution unless:
 - A. The student is required to move to another city where such distance makes attendance impractical.
 - B. There are other extenuating circumstances that the Board of Directors of Pee Dee Academy deem sufficient enough to justify releasing the parents from the remaining balance of the contract.
- 7. During the academic year of this contract, if a student is expelled or withdraws from Pee Dee Academy for any reason not stated in item #6 of this contract, the parents of the student are responsible for fulfilling the entire financial obligation of this contract and Pee Dee Academy has the right to declare the entire balance due immediately. If Pee Dee Academy declares the entire balance due immediately, the school shall have the right to collect from the parents all costs and expenses incurred in enforcing this agreement, including, but not limited to reasonable attorneys' fees.
- 8. Pee Dee Academy reserves the right to refuse any applicant admission under the guidelines adopted by its Board of Directors and to determine to which class each applicant will be assigned.
- 9. Expulsion: Students at Pee Dee Academy are subject to all rules and regulations contained in the current PDA Family Handbook. Pee Dee Academy reserves the right to expel any student for any scholastic or disciplinary action, either on or off campus, that brings discredit to the reputation of Pee Dee Academy. The affected student and parents of such student shall be notified prior to any action and shall be given the opportunity to present to the Board of Directors any mitigating factors which they might deem pertinent in writing or in person at the discretion of the Board of Directors. Any student who is expelled is subject to the conditions stated in item #7 of this contract.
- 10. Pee Dee Academy reserves the right <u>not</u> to off the student an additional enrollment contract should the student's behavior or academic performances fall below an acceptable standard as determined by Pee Dee Academy's administration and Board of Directors.
- 11. Pee Dee Academy reserves the right <u>not</u> to offer the student an additional enrollment contract should the parent behave in unacceptable ways. If the parent acts in unacceptable ways, the student may be dismissed from Pee Dee Academy.
- 12. This contract is non-transferable and shall not be binding upon Pee Dee Academy until it is executed by its Chairman of the Board of Directors.
- 13. All new students accepted to Pee Dee Academy will be admitted on a provisional basis for 9 weeks. At the end of the 9 weeks, all teachers will submit an academic report to the Head of School via the Guidance Counselor. The student's academic progress, behavior, and attendance will be evaluated. If all are satisfactory, the student's admission will become final. If all are not satisfactory, the student may be dismissed from Pee Dee Academy.
